1. July 2023 Parks and Recreation Report

Parks & Recreation Advisory Board Meeting

July 10, 2023

Recreation

- **Summer Recreation Classes** – continue to be held at the Colleyville Center and Library.
- **Texas Junior Anglers** – was held on Saturday, April 22 from 9-12pm at the Nature Center (Anglers Pond). Door prizes were handed out, as well as prizes for the largest fish. It was a great event with a great turnout.
- **Summer Camps** – Variety of camps are being held throughout the parks and indoor camps are being held at the new Recreation Center.

Athletics

- **Youth Sports Associations (soccer, baseball & softball)** – Spring seasons ended in May and tournaments were held through June. Tryouts for the fall season will occur in late July and early August.
- **Summer Coed Sand Volleyball League** – The summer league began June 12 with 7 teams playing.
- **Youth Fall Volleyball League** – Registration will begin in late July and the league will begin in September.

Tennis & Pickleball

- **Summer Tennis Leagues** – 5 leagues with 10 total teams that play out of City Park.
- **Summer Pickleball Leagues** – No summer leagues.

Senior Center

- **Summer programming** continues to be offered at the Library and the Colleyville Center.

Parks

- **Hall-Johnson Reserve Fire Station** – Installation of new landscape bed, with landscape border, plant material, sod, and irrigation.
- **Sparger Playground** – The pour-in-place is currently being patched in areas where it has worn or it has been torn. The work should take a week and the playground will re-open on Monday, July 10.
- **Beautification Team** will work on replacing the plants and trees that did not make it through the freeze and summer heat. Church Street, PW Service Center, Colleyville Center, various beds throughout the City.
- **SH26 Beautification** – The TxDOT Green Ribbon Grant project included additional trees and irrigation installed along the parkway on the east side of SH26 from Brown Trail to Cheek-Sparger. The trees included Vitex, Yaupon Holly, and Viburnum.

Master Plan & CIP Project Update

- **Overland Park is completed** – The playground and amenities have been installed. The Beautification team has also completed cleaning up the back fence, adding trees for screening, and irrigation throughout the park.
- **Senior Center Renovation Project** – moving along and the estimated date of completion is now September.
- **Recreation Center Project** – The City is working with a consultant on the design of the first phase of the renovation and will soon take it out to bid. The roof should also be going out to bid very soon.

Upcoming Parks & Recreation Projects:

- Sparger Park restroom renovation – Staff is working with contractors on providing a facelift to the restrooms (fresh paint interior & exterior, porcelain sink and toilet, etc.).
- Justice Center – pond beautification – working with HR Green (Engineering for the pond)
- Fire Stations 2 & 3 – Landscape design and installation
- Pleasant Run Competition Fields – Restroom renovation and added HVAC
- Security cameras in the parks
- Conversion of (west) basketball court to (4) pickleball courts at City Park – begins in mid-July
