Canvassing the results of the City of Colleyville General Election held May 10, 2014, for Councilmembers Place 3 and Place 4

Explanation

Reading and Public Hearing

The Texas Election Code requires the local governing body to canvass the election results not earlier than the third day or later than the eleventh day after the election day.

In accordance with the contract agreement with Tarrant County Elections, the Tarrant County Elections Administration will tabulate the results, and provide cumulative and precinct by precinct reports following the May 10, 2014, election.

The City of Colleyville received one Identification (ID) provisional ballot; therefore, the official results of the election will not have been received by the writing of this briefing. Tarrant County Elections Administration states, *"The reports will be generated Friday evening, May 16, 2014, as soon as the Voting Registrar and the Ballot Board finish processing, and advise if there is a need to count any of the ballots. Entities are probably looking at receiving reports between 5:30 p.m. and 7:30 p.m. on Friday, May 16, 2014, depending upon which additional ballots will need to be processed in tally."*

This resolution provides for the City Council to canvass the results of the May 10, 2014 General Election for Councilmembers Place 3 and Place 4, in accordance with Texas Election Code Section 67.004. Staff will provide the cumulative and the precinct by precinct results at this meeting. Staff has included the 2014 Unofficial Election Day results.

Mayor David Kelly will then issue the certificates of election to Councilmembers Place 3 and Place 4.
