## **Title**

Canvassing the results of the City of Colleyville General Election for Councilmembers Place 5 and Place 6, held on May 1, 2021

## **Explanation**

### ***Reading and Public Hearing***

The Texas Election Code requires the local governing body to canvass the election results not earlier than the third day or later than the eleventh day after the election day.

In accordance with the contract agreement with Tarrant County Elections, the Tarrant County Elections Administration will tabulate the results, and provide cumulative and precinct by precinct reports following the May 1, 2021, election. The Ballot Board met on Friday, May 7, to review the provisional and overseas ballots, and Tarrant County is scheduled to provide the official report on the evening of Friday, May 7. Staff will provide the official election results on the resolution canvassing the election.

This resolution provides for the City Council to canvass the results of the May 1, 2021 General Election for Councilmembers Place 5 and Place 5, in accordance with Texas Election Code Section 67.004.

Certificates of election, signed by the Mayor, will be issued to the Councilmembers Place 5 and Place 6. The newly elected City Councilmembers will take the Oath of Office at the regular scheduled City Council meeting on Tuesday, May 18, 2021.
